- CME* Corridor Management Entity for the Florida Scenic Highway Program (Successor to the Corridor Advisory Group/ CAG)
- FDEP* Florida Department of Environmental Protection; FRDAP Florida Recreational Development Assistance Program
- FDOT* Florida Department of Transportation; D-5 District Five; TE Transportation Enhancements (TEA 21 Federal funding source)
- FIND* Florida Inland Navigation District
- FSH* Florida Scenic Highway
- Overlook* Place to observe quality scenic setting/viewshed, possible higher elevation, seating, bicycle rack, shelter (varies)
- Trail* Shared use trail as a bicycle and pedestrian interconnected system
- Trailhead* Access point to shared trail, usually with parking, drinking water, shelter, interpretive displays, map, safety information, per ADA
- Viewshed* Particularly scenic view or vista usually to natural, cultural or historic setting, sometimes roadway itself.
